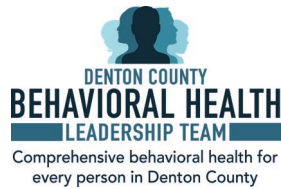

The program connects medical record with public record. Dr. Richardson mentioned the cost and need for additional funding sources to assist (~\$250,000). • Expanded navigation component at DCPH to include screening for DCPH primary care, Medicare, Medicaid, WIC, Veterans. Opportunity to train screening staff in MHFA. • Dr. Roxanne Del-Rio suggested a way to track mental health conditions within college students and how we can get all the higher education institutions together. | | |
