Thursday Jan 23, 2023 Meeting Minutes

Before meeting called to order Chief Garner of Corinth showed video about illegal drug use among children and parents

- I. Call to Order: The meeting was called to order by Dr. Lisa Elliott at 8:06 am
- II. Approval of Minutes: Chair called for motions to approve the minutes from Nov 17 Terry Widmer motioned and Commissioner Mitchell seconded. Minutes approved as written.
- III. New Participant & Guest Introductions: Lauren Titsworth- Administrator of Substance Abuse Disorders at MHMR presented on behalf of New United Way Interns: Samuel Lindgren MPH at TWU (first cohort of program) Colby Dawson JMSW program in Social Work
- IV. Report from Mental Health Authority Brittany Waymack No updates on navigators SAMSHA Grant –focused on training community members on mental health first aid, assist and ASK-suicide prevention gatekeeper training Grant from Flow foundation for counseling for uninsured youth Concluded Needs Assessment got 1005 completed responses; will get that data out and thanks everyone for helping get the survey out to the community.

Working on adjusting strategies; setting things up to start working on specific topics; continue to monitor with the navigators; getting members up and focused on where we are headed this year

Data: Juan Rodriguez & Julie Wright

Shanan has reached out to chairs to gather information about what they want to see from the Data team. We are working to provide that information that is useful to work group and committee in general.

Also looking at getting MHMR data to see if that would be useful to demonstrate their impact and the need.

Gary Henderson suggested that the group capture the data from Law Enforcement where they have a mental health case but no place to take the person; would like to capture this as lack of capacity we have as a county to handle acute mental health calls. Lori Holland stated that next quarterly meeting is coming up on 1/24 and will invite some members from the data workgroup. Shanan noted that United Way gets data from Denton, Lewisville and Flower Mound Elisa Howell noted that quality of data depends on officers changing the call type from whatever it was to a mental health call.

Julie Wright suggested that we look at an existing data base to see if this information is already captured (Lexus Nexus data base)

Suicide Prevention Committee: Scott Domingue

Committee formed 1 yr ago. Spent last year diving into data on county rates of suicide, prevention efforts, sharing ideas about we can do to make a difference. Denton CO is 2nd healthiest county in the stated but suicide rate is 11/100000 people-we are average

Reviewed the Strategic Plan-objectives and strategies

Reduce the rate of suicides per 100,000 people in Denton County 4 objectives:

-Help reduce barriers for people who encounter people in acute crisis to get those folks to care -Reduce access to lethal means

-Increase capability of Denton CO residents to identify people at risk for suicide by offering free virtual training like QPR

- support suicide prevention efforts that are being implemented in community

SCOPE OF WORK: AD HOC COMMITTEE – BEHAVIORAL HEALTH & HOMELESSNESS CONTINUUM

Problem Statement:

Behavioral health and housing systems in Denton County overlap in individuals served, but often operate independent of each other. As a result, resources (services and people) in both systems are not utilized as effectively as possible. Denton County behavioral health and homelessness/housing systems need to identify opportunities for efficiencies and improved triage and resource planning.

Objectives:

- Map Behavioral Health and Housing Systems and identify gaps/opportunities for continuity.
- Establish workflows that allow for more effective collaboration across programs.
- Establish a network of training and resource sharing between the two continua.
- Identify and secure funding to support and sustain these efforts.

Timeline:

- Pre-meeting with BHLT/HLT Chairs
- Convene COD, DCMHMR and UWDC Backbone Support Staff for initial overview and planning meeting.
- Facilitate mapping exercises with relevant collaborators and direct service staff.
- Develop an analysis identifying solutions and plans for implementation and ongoing coordination.
- Present findings to collaborators and local governments.
