Call To Order: The meeting was called to order by Dr. Lisa Elliott, Chair at 8:04 am.

Attendees introduced themselves/their community affiliation.

Approval of Minutes:

Presentation:

Kaethar "Kaye" Hashim, M.ED., CPS from Recovery Resource Council (RRC) gave a presentation on key findings from Regional Needs Assessment of substance use/abuse with focus on Denton County (Region 3)

RRC is largest non-profit in North Texas dedicated to prevention, intervention and treatment of substance use disorders and mental health. They collect, analyze and disseminate data, coordinate trainings for region providers, and collaborate on prevention strategies with stakeholders and other prevention providers.

There are 11 PRC's throughout the state divided into Texas Health and Human Service Regions; Denton County is in Region 3

Regional Needs Assessment (RNA) looks at risks and protective factors for substance use/abuse using Socioecological Model which includes Individual Peer, Family, School, Community and Societal levels.

A wide range of data points were presented including:

Thanks to Commissioner Bobby Mitchell for facilitating opportunity to present on Mental Health Navigators to Honorable Judge Andy Eads. Judge Eads signed on to make it a county initiative. Believe this work will begin some time this summer.

Commented on lack of pediatric, forensic and medical detox hospital beds

Acknowledged the outstanding work of Dr. Ann Hughes for her work in Sanger school district. The schools' programs and services related to universal mental health prevention for children and families, as well as Tier II and Intensive Mental Health Services was highlighted in Houston Chronicle. It was noted that the provision of services and resources is being rolled out in 10 more schools

b. Veterans:

TX Vet Commission Grant renewed for another year starting in July; helps with housing, utilities, transportation, childcare, and medical expenses

Have exceeded target for number of veterans served this year by 65%

c. Substance Use:

Conducted training at NCTC on how to identify and respond to people with substance abuse issues. Are targeting educational sector for this training including school districts, colleges and universities. Got off to a slow start but are seeing increase in requests. Recent request from TWU.

In June, hosting a work session to develop a story map/visual graphic that will demonstrate what is being taught in this training

Denton County Behavioral Health Leadership Team Proposed Bylaw Amendments and New Appointees July 21, 2020

Proposed Bylaw Amendments: To best represent the growing population of Denton County and the mental health demands placed upon Law Enforcement and Independent School Districts, the following amendments to the bylaws are proposed:

- 1. Increase the maximum appointee number from 36 to 54.
- 2. Remove Law Enforcement and ISDs from their current categories and give each its own category with 6-8 members.

ARTICLE VI Officers/BHLT Appointees

Section 6.1: DCBHLT Appointees

The DCBHLT shall consist of no less than sixteen (16) and no more than thirty-six (36) fifty-four (54) members. Such number may be increased or decreased by amendment to these Bylaws and the DCBHLT structure.

The DCBHLT shall be composed of appointees from the following entities.:

- (1-3) Federal and State Legislature
- (3-5) Denton County Commissioners Court
- (1-2) Denton City Council
- (1-2) Lewisville City Council
- (1-2) Corinth City Council
- (1-2) Small Cities/Towns
- (3-7) Health Systems, Hospitals, MHMR, Health Department
- (1-2) Health Insurance Providers
- (4-8) Human Systems, ISD's, Higher Education, Law Enforcement, WATCH
- (6-8) Law Enforcement
- (6-8) Independent School Districts
- (2) Community Members at large
- (1) United Way of Denton County

Denton County Behavioral Health Leadership Team Workgroup Bullet Points July 21, 2022

Children and Family Systems:

- Mental Health Navigator Progress: Lisa and Laura had a very successful meeting with Judge Eads. His desire is to make this a county initiative. Judge Eads and his staff are committed to working on the details this summer.
- The workgroup began updating and revising their strategic plan, including objectives, strategies and identifying metrics.
- Next step is to update and obtain feedback from the full workgroup on the strategic plan revisions, then present for a vote.

Substance Use Prevention:

- SUP Group had a productive working meeting and developed a draft of a flow chart of substance use treatment referrals.
- Members of SUP will participate in an upcoming Overdose Awareness Day event.

Suicide Prevention:

- Group is working to determine how to best implement routine screening in health care settings.
- SP Group hopes to find ways to effectively communicate critical information from referral sources to evaluators.

Data:

- Data workgroup is narrowing in on critical data points to collect, most likely from law enforcement and hospitals.
- Group has access to hospital data via DFW Hospital Database. It provides a wealth of information.
- Data will generally run at least 45 days behind.
