Meeting Minutes: Thursday, March 16, 2023

- I. Call to Order: The meeting was called to order by Dr. Lisa Elliott at 8:04 am.
- II. Approval of Minutes: The chair called for motions to approve the minutes. Before making motion, Terry Widmer noted an error in section C of Backbone Support report. Shanan Spencer made correction. Terry made motion; Bobbie Mitchell seconded. Minutes approved with changes.
- III. New Participant & Guest Introductions: All new participants and guests were introduced or introduced themselves.

- IV. Special Presentation from Kathy O'Keefe from Winning the Fight (Substance Abuse):
 - son overdosed/died after 3rd overdose/mixed drug intoxication of heroin, Xanax (slows respiration)
 - mission is to support substance abuse education and provide resources
 - show documentaries, work with courts, present in schools
- V. Workgroup Committee Reports: Due to shortage of time, workgroup reports were removed from the agenda.
- VI. New business: Lisa Elliott
 - a. Development of Ad Hoc Committee from BHLT and HLT (Homelessness Leadership Team)

Cross collaboration between these two teams requested by City of Denton. Megan Ball: request for collaboration comes out of overlap in the population each serves; Committee scope of work is in the packet; Courtney Douangdara reiterated that the city manager is behind this collaboration. Lisa called for a motion and vote. Terry Widmer motioned, with Bobbie Mitchell seconding. The vote to form the ad hoc committee was unanimous in the affirmative.





- b. Upcoming mental health proclamations: Shanan reminded the group that mental health proclamations will begin in April. She will send a list of sites and ask for volunteers when dates are finalized.
- c. The Mental Health Navigator positions will be up for vote at the March 28 Commissioners Court meeting.
- VII. Public Comment:

Mental Health Awareness Month Updates

- Completed 20 Mental Health Month Proclamations in municipalities throughout Denton County. This included Denton County Commissioners Court.
- Partnered with WATCH to distribute 100 "Together for Mental Health" yard signs throughout Denton County.
- Partnered with WATCH on the "Autism: A Spectrum of Support" workshop on May 5th. 221 people registered for the event.
- Partnered with WATCH to prepare the "Children's Feelings are a Work of Art" gallery. There were 69 entries across the county in 10 categories. The gallery will be on Saturday, May 20th from 11 am 2 pm at the Denton County Administrative Courthouse. The gallery is also available online at <u>watchdenton.org.</u>
- Engaging in a daily social media campaign on UWDC social media and the DCBHLT Facebook page.
- Partnered with NCTC for the "Stop the Stigma" event.
- Shanan presented to Peterbilt staff on mental health awareness and strategies for care.
- Suicide Prevention Workgroup partnered with Texas Health Behavioral Health to provide free QPR suicide prevention training.



QPR stands for Question, Persuade, and Refer

-- the 3 simple steps anyone can learn to help save a life from suicide.

Just as people trained in CPR and the Heimlich Maneuver help save thousands of lives each year, people trained in QPR learn how to recognize the warning signs of a suicide crisis and how to question, persuade, and refer someone to help. Each year thousands of Americans, like you, are saying "Yes" to saving the life of a friend, colleague, sibling, or neighbor. QPR can be learned in a one-hour course.
