Meeting called to order at 8:00 a.m.

Welcome & Introductions

Judge Barbara Gailey provided the welcome and recognized guests. She also welcomed Gary Fullerton as the new appointee from Medical Center of Lewisville.

Consideration of November Meeting minutes

The November meeting minutes of the Denton County Behavioral Health Leadership Team were reviewed and approved. Motion: Dr. Derrell Bulls Second: Chief Russ Kerbow Minutes approved as written.

2016 Meeting Schedule

Judge Gailey shared the 2016 meeting schedule with the group. To accommodate schedules and amount of time the DCBHLT meetings will be moved to bi-monthly meetings. A copy of the 2016 schedule is attached for reference.

DCBHLT Structure:

Joe Mulroy shared with DCBHLT Workgroup Charters with the group. The strategic planning committee requested the workgroups create a charter which, has been reviewed and approved. A copy of the charters outlining the deliverables is attached for reference.

Public Relations:

Logo: The DCBHLT logo concept was provided to all members via email prior to the meeting in the agenda packet. Lacrica also shared with the group that the logo had been reviewed with the Consumer Workgroup during the December meeting. A motion was made to approve the logo

concept, however during discussion it was requested by Dr. Lisa Elliott that the logo be revised to include additional silhouettes to represent children to ensure the group is inclusive of the lifespan. Elizabeth Ferring also requested that the logo be revised to reflect the vision statement as a tag line on the logo.

Motion: Dr. Derrell Bulls Second: Joe Mulroy Motion amended by Dr. Bulls and second by Joe Mulroy to move forward with logo concept subject to adding additional silhouettes and vision statement tagline with circulation to member via email for approval. Motion carried as amended

Next Steps: Lacrica will request changes to the logo and will send to the group via email in the form of an electronic vote. Majority vote will be deemed approval of the logo.

Website: Lacrica provided an update to the group on the status of the website. UWDC is now working with One Each Technologies, who also hosts UWDC to design the website as Dream Host did not have a viable option. The website template is in the process of being built.

Speakers Bureau:

Chief Lee Howell provided the group with an update on the status of the Speakers Bureau Committee. The group is looking to conduct total of 12 presentations each year; 3 per quarter. If you are member of a service or professional club and looking for a presenter, or wish to be in involved with the committee, please contact Chief Howell or Lacrica.

Meadows Mental Health Policy Institute "OK to Say Campaign":

Lacrica shared with the group that the DCBHLT has been approached by Meadows Mental Health Policy Institute (MMHPI) to partner with the "OK to Say Campaign". OK to Say is a digital antistigma movement to allow people to speak freely about mental health. Informational pieces were provided in the packet. MMHPI is currently collecting stories on the website. The partnership will allow the DCBHLT to have a mass media presence across the community and to partner with the statewide movement. MMHPI is also recruiting several celebrity spokespersons whose names will be released at a later time. A unique portal will be assigned which allows for use of materials. The goal of the campaign is to engage 200,000 people statewide and to have 100,000 people sign up as supporters.

During discussion Dr. Tim Harris advised the group to be cautious with the campaign language since MMHPI is using mental health and our team is using behavioral health. Lacrica will also share these concerns with MMHPI. Dr. Kathryn Stream also asked what is being asked of the team and Lacrica shared the main purpose is to serve as a partner, encouraging others to support the campaign (including businesses, and organizations) and to become part of a statewide movement reduce stigma. The concept of a media campaign has been explored by the Child and Family Systems Workgroup, but this partnership is more sustainable and cost effective.

Lacrica is requesting a formal approval for DCBHLT to partner with MMHPI for the OK to Say Campaign.

Motion: Commissioner Bobbie Mitchell Second: Chief Russ Kerbow Motion carried to engage in partnership.

Strategic Planning Sub-Committee Update:

Dr. Matt Richardson provided an update from the strategic planning sub-committee. The group met on December 17, 2015 in lieu of the DCBHLT meeting. Dr. Matt Richardson provided an overview of the process the strategic planning committee will use with the workgroups on the goals and objectives. Additionally, the charters outline the specific deliverables of the workgroups. Workgroups will bring goals and objectives before the committee prior to DCBHLT.

Workgroup Reports/Updates

Workgroup updates and highlights of individual workgroups were provided by the Chair of each group. A formal written report was provided in the DCBHLT agenda packet. Lacrica provided reports on behalf of Chris Martin and Tami Russell who were unable to attend.

Veterans Update: Lacrica also shared with the group that UWDC has applied for the HHSC Texas Veterans +Families Initiative Grant in response to SB55 on behalf of the DCBHLT. This is the funding that was originally released last year, but was not awarded due to legislative changes. HHSC will award 3 grantees during the pilot phase. Meadows Mental Health Policy Institute will serve as the administrators of the grant.

Lacrica and Joe provided an update on the engagement with the VAMC. The group had their 2nd meeting on January 13th. There is a need to accommodate the increased behavioral health needs in Denton County and the growing population of Veterans. The CBOC, located on Colorado is 8,000 sq. ft., and the contract is currently at the end of the 2nd extension. VAMC would like to double the space at the CBOC (16-20,000 sq. ft.) and service approximately 15,000 Veterans. The RFP for building specs will be released in early February or March for the main clinic specifications (CBOC). This process is lengthy and can take several years before implemented.

- VAMC is requesting space that can be provided for 2-3 years in-kind
- VAMC will provide the staff and IT infrastructure; wireless connection and laptops can be used to provide for faster accommodations;

• VAMC would like to locate a space that is at a minimum 3,500 sq. ft. but ideally 5,000 sq. ft. to accommodate need.

Dr. Elliott suggested asking the VA to provide the same data used for similar projects in Ft Worth and Sherman.

Community Case Management Status

Lacrica provided the group with an update on the Community Case Management Software purchased by UWDC. Funding for the software was provided by the Denton Benefit League and the Flow Health Care Foundation. Pilot partners are being explored to support the efforts of the community case management component. Commitments have been received from the Denton County Mental Health Court and the Denton County DWI Court. Other potential partners include Denton County Jail Diversion Program, Denton County Veterans Court, Salvation Army, etc. Once the system is launched additional updates will be provided.

Gary thanked Dr. Giese for his support as a member of the Flow Health Care Board.

UNT Mental Health First Aid Collaboration:

Dr. Teresa McKinney presented information about the upcoming Adult Mental Health First Aid Course that will take place on March 4th in partnership with MHMR, UNT, and United Way. This partnership will allow members of the DCBHLT to attend the course at no cost. A sign in sheet was distributed to members. Dr. McKinney also distributed fliers which provided information to members on the training. The training is evidence based and has been being taught throughout the U.S. to communities, organizations, professionals, and individuals. The training also has several tracks including: Veterans, Youth (most common), elderly, public safety, etc. http://www.mentalhealthfirstaid.org/cs/

Comments: Dr. Kathryn Stream requested that an accommodation be made in the meeting minutes to reflect the work of the UWDC staff and the team's appreciation of the work.

New Business:

No new business was made.

Public Comments: Public Comments were added to the agenda to ensure time for community input. No public comments were received.

Denton County Behavioral Health Leadership Team: 2015 Annual Report The Denton County Behavioral Health Leadership Team (DCBHLT) convened on June 11, 2015 as a result of the formal recommendation made by Meadows Mental Health Policy Institute to advocate and facilitate for system level change in the behavioral health system in Denton County. The recommendation was made after a year of fact finding through the Denton County Citizens Council on Mental Health (DCCCMH).

The team is comprised of <u>31</u> appointees and <u>3</u> ex officio members serving two year terms from: Denton County Commissioners Court, Municipal Government, Health Care Providers, Health Insurance Providers, Educational Institutions, Law Enforcement, Non-profits, Housing, and other community organizations, in addition to three ex-officios who serve in an advisory capacity.

One is a Diversion program targeting those coming out of the jail and who have been identified as being homeless have a mental health diagnosis. The other is a 10 unit Supportive Housing Program pilot.

Short Term Action Items

Review and provide feedback on initial drafts presented. Continue to finalize pilot program criteria and eligibility for both programs with the 10 unit supportive housing being the priority.

Conduct a case manager meeting among the different services agencies to allow for feedback on current supportive housing pilot draft.

Tour Cottages at Hickory Crossing in Dallas on March 9, 2016. The Cottages are supportive housing units located at City Square in Dallas. A total of 12 people from the workgroup and UWDC attended the informational session.

Accomplishments

Identifying assets already existing in the community as part of the pilot to reduce cost.

Concerns

Need to define inclusion of termination if supportive vs. permanent at intake within the Supportive Housing Model.

Accomplishments

United Way and the DCBHLT continues to make progress with the VA in establishing a more robust behavioral health care clinic in Denton County. During the February meeting, the VAMC provided the sub-committee with data on number of patient encounters at the local CBOC, number of Denton County residents who received services at other VA facilities and projected data for future years.

The VAMC also shared with the group that as a result of the DCBHLT discussions the VAMC has placed a Psychiatrist at the local CBOC, which will provide for daily face to face services. A Nurse Practitioner had previously held the position and recently retired and based on need a Psychiatrist was placed in lieu of another Nurse Practitioner.

Concerns

The majority of our programs are dependent on finding volunteers to assist with program execution. Finding an adequate number of volunteers has been challenging for some time and will require a new approach.

Program marketing will also be critical to success, for two reasons: one to raise awareness of the programs that are available for Veterans, and the second is to recruit volunteers.

The group met on 2/10/16. Scott Wisenbaker and Judge Waddill shared findings from their visit to the Houston Recovery Center program. The Houston Recovery Center offers safe, short-term monitoring and management of persons under the influence of alcohol and drugs. In lieu of jail, the Houston Recovery Center provides law enforcement with an alternative for individuals arrested for public intoxication, as defined by Texas Penal Code § 49.02.

Sgt. Cari Coker and Capt. Kevin Clark shared the DCSO mental health flow chart to the workgroup. The overview consisted of the Sheriff's Mental Health Unit primary work flow, the work flow when a traditional officer completes a mental health call, and the workflow now utilized with the MHMR triage center being operational. The group also discussed why multiple assessments are required, to which MHMR shared is a requirement by Texas statute.

On February 24th Randy and several members of the workgroup attended a meeting to learn more about the Tri-County Psychiatric Center and how a similar model might serve the needs of Denton County. One of the advantages of such a facility is the reduction in time for law enforcement. Officers. Officers in Tri-County are able to return to normal duty within 30 minutes after drop off. The former CEO of Tri-County provided an overview, purpose, and funding mechanisms for the center. Additional information is being obtained from the center to determine next steps. A follow-up meeting will be held.

Short Term Action Items

- Follow-up on additional information from Tri County related to Emergency Stabilization Unit
- Determine next steps to tailoring the model to fit Denton County.
- Finalize Discharge Planner positions with MHMR and DCSO.

Accomplishments

• Development of a small sub-committee to outline Law Enforcement video logistics. Video would be designed to offer additional training and resources for deputies when responding to mental

health crisis calls since limited training is received during the academy. Partnerships are being secured for production. A formal recommendation to the team is scheduled for late spring. Dr. Teresa McKinney is leading the sub-committee.

Short Term Action Items

Due to county contract guidelines initial IOP cannot be initiated, however a conversation with UNT will be held on March 11 to discuss potential partnership with UNT's new IOP program and the court.

NAMI is willing to share information with court staff to determine how they might assist with IOP program.

Judge Waddill did not seek funding from the Governor's office in 2016 for specialty courts. The decision was based on the infancy of the court and lack of current evaluation and graduates. Court may request funding during normal county budget cycle.

Tammy Terrell of Terrell Counseling will now be present during court sessions as the court felt the need to have a clinician present during court.

New candidates for court have plateaued. Mental Health Treatment Court will present to Denton Bar Association in April 2016 as a means of recruiting new individuals.

Develop forum to address employment for those in the court. The group discussed the possibility of a Lunch and Learn for employers in Denton County to address the need for hiring individuals with mental health disabilities and de-stigmatize the perception and attitude regarding these prospective employees.

Accomplishments

A \$1,000.00 check was presented to United Way of Denton County by an individual donor and earmarked specifically for Denton County Mental Health Treatment Court to assist with payment of psychological evaluation of clients applying for court. The county will provide invoice to UWDC for transfer of funds.

Mental Health Treatment Court will partner with United Way and ETO Software pilot to assist with tracking progression of court participants

Concerns

IOP program proposal: concerns as to whether or not probation will be willing to fund if changes are made to current IOP proposal or if a partnership presents itself. This would be in lieu of the two year contract cycle.
