V. Presentation : Sandy Hook Promise Program/ Dr. Marci Malcolm Lake Dallas ISD

- Started with the Sandy Hook Promise: Gun violence warning signs video
- Purpose of this program is knowing the signs of gun violence and mental health and ways to prevent them before anything happens.
- Free for school districts. They provide the tools to train the administrators, parent's staff, and students. Training takes 45 minutes.
- Cohesive plan in place at 5 campuses throughout the district.

3 programs and implementation

- First program is the say something anonymously reporting system. Allows adults and children to report anonymously to the system.
- System will send tips back to the school district. If there are life safety tips, they will also include Denton dispatch as well as the school district. Administrators receive tips 24/7.







- The second program is the signs of suicide. The program has two components. The first is teaching the students how to identify the signs of suicide with AST. AST is acknowledging the persons feelings, show that you care, and tell an adult.
- Other component is the depression screener that is seven questions long.
- The third program is start with hello. This program is including an inclusive culture within the school district.

VI. Homelessness Leadership Team Update. C. Cross

Data Driven Impact

- Focus on prioritizing the homeless in the county based off of their level of needs.
- The homeless most vulnerable of dying on the street are prioritize first.
- Considers their mental health, physical health, and how long they have been homeless, different level of service needs, and household composition.
- Data report will be showcase May 29 at UNT on the square.
- Data report is going to tell the story of homelessness in Denton County using multiple data source
- Frames that just one data source can tell the full story.
- Literal homelessness is a living in an emergency shelter, a car, and tent. Living somewhere that is not meant for human habitation.
- At risk homelessness is when you are at risk of losing your current or nighttime residence.
- Short term intervention is rapid rehousing. Permanent support housing is the long-term intervention serves chronically homeless population.
- Majority of the homeless population qualifies for the rapid rehousing and place them back on the road to stability.
- Working with data collaborative Built for zero based out of New York is used to get all data as accurate as possible. Primarily with the veteran data.
- Implemented consistently tracking in-flows and out-flows.
- Also leads to how you talk about homelessness to help provider prioritize the households and making sure that we are being efficient as possible in the system.
- The system allows us to know if a person inflows or outflows.
- Point time count happens once a year and is a snapshot of people experiencing homelessness within the county on any given day. Dependent on external factors.
- Age 25 and older is the main age brackets for homelessness.
- Lack of support system is a common factor in homelessness.
- Top 5 reasons for homelessness are unemployment, unable to pay rent, family/ personal illness, physical internal disabilities
- Veteran homeless population went from 21 to 7.
- Mental health and criminal justice higher contributing factors then previous data.
- Asking participants what they were exposed to as a child were abuse, neglect, domestic violence, substance use, mental health condition, household member in jail, and gang violence.





This is important data because these are questions and topics not asked previously and can help with prevention.

- Barriers of housing are lack of funds, lack of assistance, no ID, transportation, unsure how to access resources.
- Data shows number of people experiencing homelessness is decreasing.
- First time since 2016 that homeless youth have out number the number of homeless veterans.
- Cannot add the total number of students experiencing homelessness collected from the data due to the under reported data of homelessness of the youth.
- Data is used to inform the program that are implemented and resources that are mobilized.
- Have implemented goal to end veteran homelessness in Denton County by 2020.
- Partnering with the veteran's coalition in January 2020 for 100-day challenge.
- Inform the solutions of the programs implemented are through the barrier funds. Barrier fund is intended to help with additional supportive needs.
- Housing navigator approach is to centralize the housing location process.
- Denton county housing navigator successfully recruited 10 landlords to accept tenant's homeless household being assisted in local agency program since January 2019.
- On going goal is to continue data management and data improvement.
- Adding system to dashboard to accurately analyze and improve the data system as a whole.

- New refurbished building at 406 S. Carrol Blvd with 2 psychologists and 3 psychiatrists.
- Support given to veterans with mental health within the community
- VA building going to be open and available sometime around June.
- Veteran's homeless standout going to be on the third Thursday in October.
- The homeless stand out is when Denton VA collaborates with Dallas VA and invite homeless veterans to come and see them for support giving them meals, sleeping bags, coats in the winter months to help deal with the elements.
- Number of homeless veterans are declining

- Continuing to work on pre-trail and pre-arrest diversion.
- Crisis stabilization center discussion expanding their capacity
- Mayhill requesting 9 million dollars from health and human services center this grant will allow a 30-bed expansion that will allow law enforcement to identify people believed to have mental health issue to be taken to this facility.
- Mental health court continuing to have success and graduations.
- Planning and zoning bill passed the night of May 15, 2019.

Short Term Action Items

- At the June meeting, the Workgroup began to identify unmet Veteran needs in Denton
 County for the purpose of establishing new strategic goals. Unmet Veteran needs include:
 resources for Veterans who are aging, in need of memory care, isolated, or lonely, and
 caregiver support; Veteran-specific Domestic Violence resources; adequate in and outpatient
 substance abuse treatment; money management; adaptive physical training; and medical
 benefits training for both Veterans and local hospitals.
- Representatives from Cedar Crest Behavioral Healthcare System presented information on NAMI Homefront, a free 6-week military cultural competency training for family, friends, and significant others of Military Service Members and Veterans, as well as information on Veteran Spouse Resiliency Groups. The Workgroup will explore establishing a Veteran Spouse Resiliency Group in Denton by first identifying potential trainers.
- The Workgroup will continue developing and updating a new strategic plan.

Accomplishments

 The Workgroup has achieved many of the goals identified in its current Strategic Plan and is ready to pursue new strategic goals alongside the DCBHLT, including the new VA Annex which opened on July 8th.

The Workgroup met on May 21st, June 18th and July 16th 2019. Short Term Action Items

- Exploring how to bridge the gap between QMHPs, jail, and receiving mental health service agency. Meeting with a QMHP could be incorporated into mandatory orders upon release from jail.
- Workgroup has begun identifying how new legislature surrounding mental health will affect Denton County services and processes.
- Workgroup will begin developing and updating a new strategic plan in August.

Accomplishments

- Jail Administration is quickly moving individuals experiencing a mental health crisis to psychiatric treatment
- Barriers to receiving medication for individuals who are being sanctioned for a short period of time have been resolved.
- City Council approved Solutions of North Texas to expand their facility to an additional 100 beds as well as a detox unit, though additional funding is needed.

Concerns

- 1) QMHPs and Case Managers connecting with individuals upon release from jail is a barrier. Additional training is needed on follow-up care.
- 2) Lack of substance misuse rehabilitation and treatment options for unfunded patients in Denton County.
- 3) Lack of medical stabilization at Mayhill's Crisis Stabilization Unit (CSU) is a barrier to officer's transporting individuals directly to CSU.

Short Term Action Items

- Okay To Say (O2S) is re-establishing momentum. O2S is now targeting person's 35 years old and younger, specifically focusing on their inner circle (i.e. family, friends, social supports) with the goal of providing individuals with necessary tools needed to recognize when someone is struggling and how to approach them. Meadows Mental Health Institute will send out quarterly O2S newsletters to participating agencies, is updating their website, and will be starting a focus group in the Fall. UWDC recently entered into a shared partnership agreement with O2S, UWDC, and the DCBHLT. This Workgroup could be added to the existing agreement.
- Discussed human trafficking in Denton County. Laura shared that the Governor's office is offering additional screening trainings and is targeting specific health professionals to screen at schools and other community entities. The Workgroup's role in human trafficking is prevention, resiliency, identifying red flags and making appropriate referrals.
- Workgroup will begin developing and updating a new strategic plan in August.
