Hybrid Meeting

Welcome and Introduction

Dani Shaw calls the meeting to order. Dani requests participants for the nomination committee. Meeting not at quorum, approval of meeting minutes will be voted in October meeting.

Denton County Housing Programs

Olivia Williams introduces the four different local organizations (Our Daily Bread, MHMR, Giving Grace, and CCA) who will be speaking on the three types of housing programs in the county.

TBRA Through Our Daily Bread (ODB)

Crystal Madrigal introduced Tenant Based Rental Assistance, which helps with rent and utilities for 12 months out of 24 months to ease families into getting back into housing. During their time in the program, clients received rental and utility assistance and case management. According to the data, 13 households were housed. For the clients, 30% of their income must go towards rent. Crystal emphasized that ODB prioritizes timely rent payments and works to build relationships between case managers and landlords.

Barriers. Crystal reports that barriers lie in adherence to case management, building rapport, and misconceptions about what program provides and program expectations.

Rapid Rehousing Through Christian Community Action (CCA)

Daphne Houston introduces Rapid Rehousing Program for 20 households per year. According to Daphne, the program was approved through 2026.

Barriers. Finding landlords who would take higher risk clients, building relationships with apartment managers to counteract this. Another barrier reported is that clients tend to drop off after getting housed, so case managers must find ways to continue to engage clients. Daphne stressed the significance of clients connecting with their case manager, and for case managers to work on understanding where client is coming from.

TBRA through Giving Grace

Sherri Williams introduces their TRBA and Rapid Rehousing Programs. Sherri reports that these programs were intended to aid in developing and obtaining housing stability among homeless individuals. Referrals for these programs come through HMIS and vacancy pilot program. Rapid rehousing has assisted 7 families and 3 individuals. Rapid rehousing asks for 10% of client's gross income but takes clients with little to no income. The programs are intended to assist clients with

rent until they are making more income. Sherri reports that the program includes childcare assistance, life skill classes to aid clients and build community, job search preparation, and classes on maintaining household stability.

Connections Supportive Housing Through MHMR with Laurie Common

Laurie Commons reports the progress of the Connections Supportive Housing program, stating that 53 singles and 3 families were housed so far, for a total of 60 individuals altogether. Clients must meet the HUD definition of homeless and then get put through coordinated entry. Laurie attributes the success of the program to great case management, access to mental health services, and the providing of transportation to medical and mental health appointments and food pantries. Laurie reports purpose as being to help vulnerable populations with a physical or mental disability.

Barriers. Laurie reports barriers resulting from the stigma against homelessness, criminal activity by clients, substance use, evictions, and limited funds for personal items.

Permanent Supportive Housing Program Through Giving Grace

Ty reports that this program is intended for individuals who have been homeless over 12 years and have a disability. In this program, it is reported that individuals are housed first and then barriers are addressed. Giving Grace provides case management once a month and home inspections. Skills classes are also provided for the clients.

Barriers. Ty reports that clients have engaged in behaviors that have them discharged from the program such as clients who have attacked landlords in the past, engaged in criminal activity in their provided housing, engaged in substance use, or hospitalized, in rehab, or in jail for 90+ days. Ty reports the need for scaling up stability and sustainability.

Action Items

- Convene with landlords and educate with police department on how to interact with this population
- Scale up Rapid Rehousing Initiatives
- Expand PSH
- Increase access to affordable housing
- Enhance support services

Public Comment

Elena Shehan reported on the Denton County Homeless Coalition work group is discussing the Texas Homeless Network (lead agency) and their proposed modernization for the Balance of State that is being evaluated and will bring changes to how the 215 counties might align.

- Landlord Engagement assisted with 7 housing referrals and completed 4 successful move ins

- Identifying training resources to support agencies staff
- Permanent Supportive Housing beds are at capacity for Denton County

OBJECTIVE & GOALS 2023-2025:

OBJECTIVE & GOALS 2023-2025:

Meeting Summary (provide meeting date and items discussed during meeting)

This group is currently in the knowledge-gathering phase, identifying gaps in the current system as it relates to the unhoused population and determining what can be done on a local level to address these gaps.

Short Term Action Items

• Continue identifying organizations at the response systems' primary integration level.

Accomplishments

- Final draft of updated SIM map distributed to group
- Recommendation to focus on data collection to support the build out of the continuum of care
 - Create and implement a planning team to coordinate discharge and care for individuals with high rates of crisis service utilization
- Recommendation to collaborate on community grant opportunities for the system level opportunity to bring technical training to agencies

Concerns

- The need for hard data to quantify the county need, such as average number of people served, cost per person/per day
- There is a lack of adequate mental health diversion options for law enforcement
- New legislation that allows law enforcement to transfer responsibility of care

DATA Workgroup: October 2024

CHAIR: STEPHEN COFFEY

OBJECTIVE & GOALS 2023-2025:

Identify ways to integrate data support for other HHLT workgroups to advance funding and advocacy efforts

Meeting Summary

There are currently 610 households actively experiencing homelessness on our Housing Priority List. The 610 total number for breaks down into:

47 families563 individuals21 fleeing domestic violence

33 Veteran households175 households experiencing chronic homelessness

Denton County school districts' data was updated in March 2024. The two largest school districts reported the following:

Denton ISD: 481 students (18% decrease from February 23; 587) Lewisville ISD: 888 students (13% decrease from February 23; 1024)

Housing intervention prioritization breakdown:

Diversion Services: Households (18.2%; 111) Rapid Rehousing Intervention: Households (59.7%; 364) Permanent Supportive Housing Intervention: Households (22.1%; 135)

The team discussed the importance of creating and conducting surveys to gather crucial data. One survey will focus on collecting feedback from other workgroups to identify shared data needs and potential collaborations. Another survey will be used to assess agency experiences with the diversion workflow, informing the development of targeted training and support programs. Additionally, the team will review the previous post-housing survey and conduct research on homelessness recidivism to improve post-housing outcomes.

Additionally, the workgroup discussed the need for refined tracking of individuals who qualify for the Permanent Supportive Housing (PSH) program but don't meet the program requirements. The goal is to better understand the population served by PSH and to identify those who are experiencing high vulnerability but may not qualify for the program.



Short Term Action Items

Create survey to gather feedback from other workgroups to identify data needs and potential collaborations.

Create survey to develop a strategy to encourage and support agency utilization of the diversion workflow through training and program focus.

Review previous iteration of post-housing survey process, research recidivism of homelessness in previously housed clients.

Healthcare: October 2024

OBJECTIVE & GOALS 2023-2025:

- Increase access to healthcare services for people experiencing homelessness
- Increase community resources for healthcare workers
- Identify data points from participating organizations and agencies in Denton County

Meeting Summary

The workgroup discussed next steps in medical respite planning considering data needs to support priorities. There was discussion about the Community Health Improvement Plan priorities that were presented on Sept 26th, and how recuperative care solutions are needed.

Short Term Action Items

- Continue to work with agencies and medical providers for healthcare needs assessment
- Continue to identify stakeholders and build membership

Accomplishments

- Collaborative implementation of an external screening form to identify guests and their needs that are leaving hospitals and potentially arriving at Our Daily Bread. Update, HIPPA compliance agreements are being reviewed. HCA declined, THR is still in review. Mayhill is interested in sending to their compliance department for review.
- Invited faith-based organizations to the group

Concerns

• The gap in available healthcare services for people experiencing homelessness and unmet health needs are a growing concern for agencies.

Denton County Homeless Coalition: October 2024

OBJECTIVE & GOALS 2023-2025:

- Expand agency participation in PIT Count
- Strengthen education on housing efforts
- Increase funding to support housing stability
- Increased access to information

Meeting Summary

In the August meeting, the Coalition wrapped up HUD CoC funding support letters, with the final presentation from Denton County Friends of the Family.

In the September meeting, the Coalition discussed the PRO Housing Agency and Community Feedback for both the City of Lewisville and City of Denton applications.

Additionally, progress towards the goals the Coalition created at the end of 2023 was discussed to ensure advancement in strategic planning was occurring on an ongoing basis.

Short Term Action Items

- Recruit more volunteers to participate in planning and outreach

September 2024 Backbone Support Updates:

Denton County Housing & Homelessness Leadership Team

- Balance of State CoC modernization preliminary review to examine how realignment of service areas could impact Denton County
- Supporting Our Daily Bread for Spring semester to recruit interns to complete intake, coordinated entry assessments, and goal setting.
- Applying for a grant to supplement diversion housing navigation to include, rehousing, HUD category 2, and support the landlord engagement manager.

Denton County Behavioral Health Leadership Team

- CredibleMind has reached over 3,000 users and has launched a new section called Learning Lab that includes more directive series that guides the user to interact with specific topics. Additionally, a new tool, "Practices" launched and it targets a deeper dive of interactive tools.
- Starting to discuss the 10 year anniversary of DCBHLT planning

Denton County Workforce Success Leadership Team

- VITA planning is kicking off and we are actively hiring an Economic Mobility program manager that will oversee VITA during the tax season and continue to expand the mobility efforts year-round.
